One suggestion was to put a form in with snail mailed invoices. Or just mail out a questionnaire form. Dale said that the cost of this was around \$600 plus many hours the one time they did this. He asked the Club if we thought this was important enough to do it this way.

Second – Suggestions were given about when to activate or deactivate gate cards and getting the needed information.

Heather stated that it is the Boards responsibility and common curtesy to have this information in order to contact everyone. Dale said that the Bylaws require this.

This brought up the topic about how much information the Club needs. As mentioned in the past, we need members to tell us how much shooting experience they have. Getting insurance for gun clubs is becoming very difficult. If we can show them that we have a **PERCENTAGE** of ex-military, ex-police, hunted all your life, etc., it makes it easier for us to get insurance. Several members felt that giving us their shooting background as well as their **BASIC** personal information was intrusive. At one point it was asked if it is legal for the insurance company to have this information. AGAIN, the insurance company does not get your personal information.
